Background and Philosophy: Though India has many high volume centers, there is very little clinical research being done in proportion to the clinical material available. Without clinical research and looking at the outcome, the scope of improving quality care and improvising new protocols is limited. In addition, there is paucity of fund to support these young professionals who are keen to do research. Keeping this in mind, it was decided by the organizers of Cleft2017, Chennai that the interest of excess of 50 lakhs from International Cleft Congress 2017 will be used as sustenance grant for the Research Fellowship. **The Research Project will be of Clinical research and not basic science research.**

8	Utilization of Funds	
	Corpus Funds	Interest of the corpus will be utilized as a financial support/stipend to the fellow. It is a total of Rs 25000 per month (Rs 20000 to be paid monthly and the remaining Rs 5000 to be paid cumulatively after the submission of final project and approval of the guide.
